NOTICE OF INTENTION TO CIRCULATE RECALL PETITI

TO THE HONORABLE JUDGE THEODORE C. ZAYNER:

Pursuant to Section 11020 of the California Elections Code, the undersigned, registered qualified, voters of the COUNTY OF SANTA CLARA, in the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of JUDGE SUPERIOR COURT, in the COUNTY OF SANTA CLARA, California, and to demand election of a successor in that office.

The ground for the proposal recall are as follows:

Judges' median annual salary in San Jose, CA is \$183,487, as of April 26, 2016. Zayner was appointed to office in 2009 (wasn't elected), ran unopposed in 2012 (wasn't elected, repeatedly a judge without appearing on ballot), ignores the law, rigs cases, conspires with other judicial officers to deny civil rights, including right to appeal, and right to real property, keeps his real estate in trusts so he doesn't have to pay taxes on his property, is sneaky, deceitful, dishonest, treacherous, seditious, subversive, rules from the bench, ignores the law, disobeys the law, disobeys California Constitution, disobeys federal Constitution, eviction judge, complicit in fraudulent foreclosures, gets free mortgage loans as bribes, bribed by County government, violates oath of office, denies people civil rights, ignores police, sheriffs and attorneys misconduct, carries no insurance for his office required by law, conceals conflicts of interest, commits fraud upon the Court, limits access to court, makes erroneous rulings, commits fraud upon litigants, undisclosed financial conflicts of interest, allows civil asset forfeiture and theft without due process, refuses to step aside when required by law to do so, ignores people's evidence, abuses discretion, performs judicial misconduct, arrogant, disrespectful.
